

**AMERICAN STUDENT MARKETING DATA LICENSE AGREEMENT: MULTIPLE-USE LICENSE**

**APRIL 2017**

American Student Marketing, LLC (“ASM”), grants to you (“Customer”) the right to use ASM data made available to Customer pursuant to an order (the “Product”) under the following terms and conditions:

ASM grants Customer a nonexclusive limited license to use the Product, authored by, and/or licensed to ASM. Customer agrees that the Product is proprietary, copyrighted work of ASM and contains confidential information that derive independent economic value, actual or potential, from not being generally known to, and not being readily ascertainable by proper means by other persons who can obtain economic value from its disclosure or use; and is the subject of efforts that are reasonable under the circumstances to maintain its secrecy. Customer agrees that it will not commit or permit any act of omission by its agents’ employees, or a third party that would impair ASM’s copyright or other proprietary rights in the Product. The Product is licensed to Customer on a confidential basis for the internal use of Customer. The Product may not be disclosed or otherwise made available in whole or in part to any third party, in any manner. The Customer may make use of the Product in connection with its marketing, planning, sales or other business activities and only as detailed in the Insertion Order executed between the parties.

The Product may be used for a multi-use purpose and only as explicitly stated in the insertion order signed by customer prior to delivery. Customer will not use Information as a factor in establishing an individual's eligibility for (i) credit or insurance to be used primarily for personal, family, or household purposes, or (ii) employment. After use or early termination of this License, the Customer shall immediately destroy all Product (including any copies and portions that may be contained in a derivative work of compilation of the Customer) and, if requested by ASM, provide documentation of such destruction. No ASM Product may be overlaid, appended to, appended from or otherwise integrated with Customer’s data. Derivation of additional information on the file using social media or any other means of extracting additional value from the file is strictly prohibited unless such action is expressly sanctioned by ASM. Customer shall not copy, or otherwise record in computer readable or human readable form, the Product or documentation. This Agreement specifically prohibits any activity of the Customer or anyone else that would alter, modify, or adapt the Product or documentation, including, but not limited to, translating, decompiling, disassembling, or creating derivative works or another similar product.

ASM retains all ownership rights (including copyrights and other intellectual property rights) in the Product, in any form, and Customer obtains only such rights as are explicitly granted in this agreement. Customer will use the Product in compliance with all applicable local, state, federal and international laws, rules, regulations or requirements. Customer must maintain reasonable security procedures and practices appropriate to the nature of the information to protect the Product in Customer’s possession from unauthorized access, destruction, use, modification or disclosure. Customer shall provide ASM prompt written notice upon discovery or notification of any actual or potential unauthorized access to or use of the Product (a Security Breach) and immediately and at its own expense investigate and take all steps to identify, prevent and mitigate the effects of any Security Breach. Customer shall promptly provide to ASM a detailed description of the incident, the Product accessed, the identity of any affected consumers, and such other information as ASM may request concerning the Security Breach and conduct any recovery necessary to remediate the impact and bear any cost or loss ASM may incur as a result of a Security Breach, including any cost associated with ASM notifying any effected consumers. ASM may elect to terminate this Agreement prior to expiration upon written notice in the event of a breach thereof by Customer.

**LIMITED WARRANTY**

ASM warrants that the Product will substantially conform to published specifications and to the documentation. ASM will replace defective media or documentation provided you return the item to ASM within ninety (90) days of the date of license. If ASM is unable to replace defective media or documentation, ASM will refund the license fee. These are your exclusive remedies for any breach of this warranty. ASM does not make any warranty, either express or implied, as to the quality, performance, merchantability or fitness for a particular purpose of the Product. In addition, ASM does not warrant the accuracy or timeliness of the information contained in the Product. In no event will ASM be liable for direct, indirect, special, incidental, or consequential damages (including loss of profits) arising out of the use of or inability to use the Product or the documentation, even if advised of the possibility of such damages. In no case shall ASM’s liability exceed the amount of the license fees paid by Customer.
